# Cosentino Group General Conditions of Sale

#### 1. Scope and validity.

These General Terms and Conditions of Sale shall apply provided that no other specific terms and conditions have been expressly agreed between the parties in writing. Such conditions will take precedence, where applicable, over the general conditions pertaining to the purchaser.

The client acknowledges that the General Conditions were made available to it prior to entering into the commercial relationship to which said General Conditions apply. The sale of products by COSENTINO to the client implies the client's acceptance, in full and without reservation, of these terms and conditions, which are automatically and lawfully incorporated into the commercial relationship between the parties.

The signature of the delivery note or invoice implies the acceptance of these General Terms and Conditions of Sale, as well as the quality, quantity and condition of the merchandise.

#### 2. Prices.

The sale prices of the products shall be those established in rates communicated by COSENTINO to the client, or the special conditions agreed by COSENTINO and the client. The corresponding taxes must be added to said prices.

COSENTINO may modify the sales prices of the products at any time. The increase in the product price will not affect orders being processed that have been expressly accepted by COSENTINO.

COSENTINO reserves the right to establish a credit limit for each client and to make deliveries subject to this limit and/or the presentation of sufficient payment guarantee. In the event of any payment delay, COSENTINO may proceed to recover the merchandise for which payment is pending and/or initiate the corresponding legal action.

#### 3. Warranty and delivery of products.

COSENTINO guarantees that the products are sold according to the terms of the specific product warranty made available to the client and that the latter declares that they understand and accept.

Placing an order constitutes, on the part of the client, a commitment to purchase, COSENTINO reserving the right to suspend or cancel orders in the event it should consider the solvency guarantees provided by the client as insufficient.

The delivery periods agreed with the client will at all times be merely indicative, all deliveries being subject to stock availability. COSENTINO accepts no responsibility for situations in which delivery fails or is delayed.

The client must examine the merchandise as soon as it arrives, informing COSENTINO in writing as soon as possible and, in any case, within seven (7) days from the delivery date regarding products it may have identified as having any visible and external defect. Materials will be understood as having been delivered insofar as they have simply been made available to the purchaser at COSENTINO facilities.

Any exchange or return of products consisting of complete slabs that the client may wish to make within thirty (30) days of their receipt must be verified and authorised by COSENTINO.

Likewise, any exchange or return of complete slabs that the client may request after thirty-one (31) days have elapsed following the date of receipt of the products, and up to ninety (90) days following the receipt thereof, must be verified and authorised by Cosentino and a commission equivalent to 25% of the sale price of the products will apply.

Returns of complete slabs will not be accepted if more than ninety (90) days have elapsed following receipt of the products.

#### 4. Packaging and transportation.

Packaging, if any, is not included in the prices given and will be the responsibility of the client. Transportation costs, handling and risks are the responsibility of the client, even if transportation is carried out by third parties commissioned or managed by COSENTINO, based on the understanding that the handling agreed with COSENTINO takes place on behalf of the client.

#### 5. Quality and measurement.

No claim will be accepted if the material has been used or has undergone any process of transformation, treatment or modification by the Client.

The measurements to be allocated shall be obtained by proportionally determining the bevels and commercial rises in blocks or slabs which have simply been sawn, and these shall be the actual measurements if their edges have been cut to a fixed size

In the case of natural stone, the samples provided do not imply that the project supplied shall be absolutely identical in tone and veining, since these are natural products which, although carefully selected and produced, may be subject to variations in tone, grading and composition. Variations naturally occurring to the product cannot be considered to be defects and any claims in this regard will not be accepted. The client may examine the product at our facilities. Any claim due to a variation or defect of the material must be made by the purchaser on delivery of the merchandise or within a maximum period of eight (8) days following its receipt.

#### 6. Payment method.

Payments shall be made using the method and within the timeframes established in the corresponding invoice. Without prejudice to the above, except where COSENTINO and the client have expressly agreed otherwise, payments shall be made by charging the client's designated account for such purposes. Whenever the client issues a new order that is accepted by COSENTINO, the client expressly authorises COSENTINO to present the corresponding invoice for payment from the bank account provided by COSENTINO, as reflected in the corresponding invoice. The client thus expressly acknowledges that it will not have the right to request that its bank return the invoices corresponding to purchases issued by COSENTINO, pursuant to the provisions of article 48 of Royal Decree-Law 19/2018, of 23 November, on payment services and other urgent financial measures, ("RD 19/2018"), or any other regulation that may apply.

In any case, and for avoidance of any doubt, the client expressly waives the return of any charge made against invoices issued by COSENTINO, in accordance with the provisions of article 34 of RD 19/2018 or any other regulation that may apply.

The client authorises COSENTINO to share the declarations contained in the present clause with the financial institution through which it makes payments. Without prejudice to the foregoing, COSENTINO reserves the right to demand payment by other means (cheque, transfer, promissory note, etc.) at its discretion.

In the event of non-fulfilment, either in whole or in part, of the payment obligations taken on by the client, COSENTINO shall be entitled to terminate any sales remaining unpaid and may also seek damages and payment for the corresponding interest. Likewise, the client must cover any financial and banking costs resulting from the delay in payment.

COSENTINO shall be the sole owner of the products until these have been paid for in full by the Client.

#### 7. Responsibility.

Beyond circumstances arising due to the defective nature of the products, any claim for loss or damages made by the client is expressly excluded, except in cases of serious negligence or fraud. COSENTINO's contractual responsibility is limited to the value of the sale of the products. COSENTINO cannot be held responsible by the client for any loss of income, inactivity costs or, in general, losses of any kinds that the Purchaser may incur due to the non-delivery or delivery of defective products.

The client assumes full responsibility, theretofore exonerating COSENTINO, for any damages arising from the inappropriate use, storage, conservation, preparation or handling of the products.

To these effects, COSENTINO has provided the client with all documentation and instructions required for the safe and proper use of the products. Likewise, COSENTINO is exempt from any responsibility against any legal, contractual or extra-contractual claims by third parties that may arise from activities carried out by companies external to COSENTINO for the processing, handling or installation of the products. The client is responsible for the fulfilment of the legal provisions in force on environmental matters, and, especially, the management of waste produced as a result of handling and preparation of materials acquired or their packaging.

Likewise, COSENTINO shall have the right to modify the corresponding delivery periods for the products as agreed with the client and/or the present General Conditions of Sale due to circumstances beyond its grasp or control, such as, inter alia, changes to legislation, natural or social circumstances, legal circumstances (such as restrictive regulations on foreign commercial operations, changing market conditions that may substantially affect or restrict the supply or price of the products, such as unforeseen tariffs or taxes), or reasons of force majeure.

#### 8. Health and safety requirements.

The client shall comply at all times with any applicable regulations with regard to the application, handling, storage, production and provision of the products sold by COSENTINO.

Products acquired by COSENTINO may contain Crystalline Silica (see the respective label and Safety Data Sheet). Processing the products incorrectly or without the appropriate safety measures can result in serious illness, such as silicosis or lung cancer. Consult with a trained safety and hygiene professional for the implementation of any occupational health measures required to contain the source of dust, such as use of manufacturing tools with a water supply, and ventilation systems ensuring air circulates properly. Employees of the professionals who carry out the final processing of the products have a responsibility to inform their workers and ensure that the workplace complies with the applicable local regulations to limit occupational exposure to Respirable Crystalline Silica.

In particular, the client must carry out regular risk assessments at each of its work sites in accordance with the applicable industry regulations and implement the appropriate risk control measures.

All slabs are accompanied by a safety label that lists the risks identified. #### 9. Protection of personal data.

In accordance with the applicable legislation on data protection, you are hereby notified that the personal data pertaining to these conditions will be held in a file by COSENTINO, with registered address at Ctra. Baza a Huércal – Overa, Km. 59 – 04860 Cantoria (Almería), for the purposes of managing

the commercial relationship. In addition, the parties guarantee compliance with the duty of information with regard to their employees whose personal data are communicated between the parties for the maintenance and fulfilment of the contractual relationship. The legal basis for the processing of the subjects' data is that it is required for purposes of this agreement being entered into and performed, as well as the legitimate interest of the data controller.

Your data will be held for a period of 15 years so as to comply with the company's legal obligations. You may, however, exercise your rights of access, rectification, cancellation/deletion, objection, limitation or portability by writing to the address indicated above or to the Data Protection Officer: gdpr@cosentino.com, providing a photocopy of your Identity Card or equivalent document and specifying your request. In addition, if you believe that your right to the protection of your personal data has been violated, you may file a complaint with the Spanish Data Protection Agency (www.aepd.es), or any other competent authority.

#### 10. Cosentino's industrial property rights.

The client acknowledges that the trademarks and brand names that identify COSENTINO and its products are the sole and exclusive property of COSENTINO and that it may not make any claim or exercise any right in relation to them. The trademarks and brand names shall be used by the client for the sale of the products, clearly indicating the Client's relationship with COSENTINO, that COSENTINO is the owner of the trademarks and brand names, and complying in all circumstances with the guidelines and requirements established by COSENTINO.

In this regard, the client undertakes not to register nor request the registration of any name, trademark, brand name, internet domain, social media profile, or any other kind of industrial or intellectual property that contains or resembles the trademarks and brand names that identify COSENTINO or its products in a way that may cause confusion in respect of the origin of the products or the relationship of the client with COSENTINO.

In the event that the client wishes to design, implement or use a website for the promotion and sale of COSENTINO products, it must obtain prior written approval from COSENTINO with detailed agreement of the characteristics, design and content of such website as well as the name and domain it will use. Otherwise, COSENTINO will be entitled to require the Client to cease using said website at any time.

In addition, COSENTINO may require that the client use any of COSENTINO's websites instead of any alternative website. If, for any reason, the client registers any name, domain, trademark, social media profile or brand name that contains, resembles or is the same as any trademark or brand name registered or used by COSENTINO, the client shall be obliged to transfer ownership of such registrations to COSENTINO at no cost to the latter immediately upon COSENTINO's formal request.

The Client will not use any of the trademarks, brand names or copyright belonging to COSENTINO as part of its company or trade name.

#### 11. Assignment and subcontracting.

COSENTINO is authorised to subcontract the manufacturing and/ or delivery of the products to third parties, as well as to assign the provision of any other services arising from the present General Terms and Conditions of Sale.

### 12. Applicable law and jurisdiction.

The present general terms and conditions of sale shall be governed by Spanish law and any other law that may apply to the commercial relationship between the COSENTINO subsidiary and the Client.

In the event of discrepancies in relation to their interpretation, application or execution or any dispute in relation to the terms set out in the present general conditions, the parties agree to be bound by the jurisdiction of the courts and tribunals of the city of Almería or any court that may be competent to resolve any dispute between the COSENTINO subsidiary and the Client, even though COSENTINO may bring any proceedings which may be in its interests before an alternative jurisdiction.
